

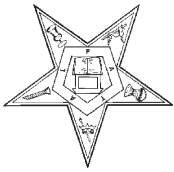

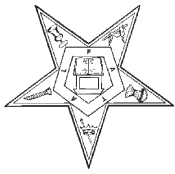

Eel River Empire Lodge No. 147

Brethren,

As you are aware, we are still under the directive from Grand Lodge, not to hold any meetings while under the virus restrictions. This has certainly left our plans in disarray but we will survive this.

As there isn't any current Lodge news, perhaps our members would be interested in a little history of your Lodge.

It is written in the minutes of Humboldt Lodge No. 79 that on August 2, 1860, a petition to the Grand Master was read. This petition was signed by nine Master Masons in good standing residing on or near the town of Hydesville in Humboldt County, requesting that a Masonic Lodge formed there. We also learn that Humboldt Lodge recommended to the Grand Master that a dispensation be issued to form such a Lodge. The dispensation was granted on August 25, 1860.

The passage of time and devastation of fire have destroyed many of our earliest records and little is learned of our history until October 4, 1866. However a preserved Tiler's Register indicates that a meeting of Eel River Lodge was held under dispensation in Hydesville on January 5, 1861. Present were the following officers: Senior Warden Pro Tem E. L. Davis, Junior Warden E. D. Holland and Senior Deacon Jacob DeHaven. Members were: John P. Langdon and Wesley Underwood. Visitors were: E. Ettlinger of Warren Lodge No. 10 of Jacksonville, Oregon, H. Murray of Humboldt Lodge No. 79 and George Hiller of Clinton Lodge No 119 of Horsetown California.

On February 2, 1861, another meeting was held and the following officers were present: Worshipful Master Thomas Hart, Senior Warden E. L. Davis, Junior Warden E. D. Holland, Secretary S. Ettlinger, Treasurer H. P. Larrabee, Senior Deacon J. C. Conner, Junior Deacon Jacob DeHaven and Tiler H. Bradford. Similar meetings were held on March 2, and April 6, 1861. This narrative may be continued if we are still under lock down next month.

Hello from Eureka Court,

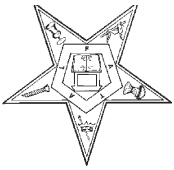

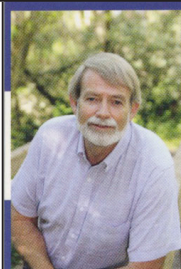

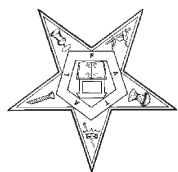
