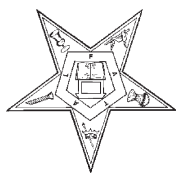

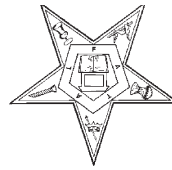

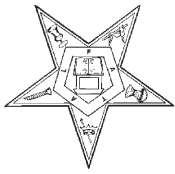

History Continued:

The Lodge continued under dispensation until May 17, 1861 on which date it was regularly chartered as Eel River Lodge No. 147 with the following officers and members present: Worshipful Master Thomas Hart, Senior Warden Charles H. Pine, Junior Warden Edward D. Holland, Treasurer H. P. Larrabee, Secretary Elisha L. Davis, Senior Deacon Jacob DeHaven, Junior Deacon John C. Connor and Tiler Auldwin H. Bradford. Master Masons present were William S. Broadwater, Henry J. Davis, John P. Langdon, James W. Neal, Westley Underwood, and Reason Wiley. Fellow Crafts present were Levi Lindley, Spencer C. Corwin, John Moore and Henry Seavern.

It is interesting to note that the meeting place at Hydesville was owned by the Lodge jointly with the Hydesville School District which might indicate that the building was used as a school during the daytime. The Lodge later disposed of its interest in the building to the Good Templars for the sum of \$250.00 so it evidently was not a very pretentious building.

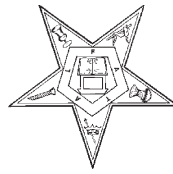
The Lodge was moved to Rohnerville. We have not been able to learn the exact date, but from our records, we know that it was sometime prior to 1866. In this location it continued for a good many years where again it apparently owned its own hall. However, the records do not show how or when it came into possession of the building. From outside information, we learn that this building was later completely destroyed by fire and that the Lodge was then moved into the McNeil Hall at Rohnerville where it remained until January 1912. On December 11, 1911, a resolution was presented and unanimously adopted to change the place of meeting to Fortuna and on January 27, 1912 the Lodge held its first meeting in Fortuna in a building known as Friendship Hall, jointly owned by the Odd Fellows and the Knights of Pythias. To possibly continued next month.

Dear Masonic family and Brethren,

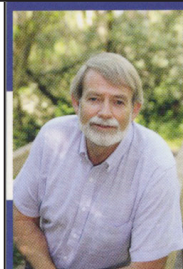
