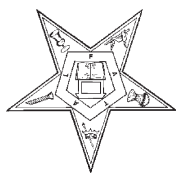

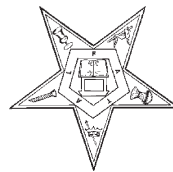
Now, more than ever, take your obligations to heart, and live the Masonic ideals.

Brethren,

History Continued

Getting out to lodge meetings in those days was often accomplished only with considerable difficulty, yet the lodges never seemed lacking in attendance. The early records show quite regular attendance by it's members whom we know lived a considerable distance from the lodge hall. They come over rough mountain trails by horseback, they came by foot and even by boat down the Eel River. Two and even three days were consumed by a trip to lodge and return.

Lodge was convened at 6PM during the summer months and at 7PM during the winter and at times must have lasted nearly all night for we often find all three degrees being conferred at one meeting.

It is surprising the number of petitions for degrees that were presented in the early years of the lodge. Scarcely a meeting was recorded that petitions were not presented. Sometimes as many as five. However, all was not "grist that came to the mill" for frequently the "box was declared foul" and the candidate was rejected. Fees were \$25 for each degree and were paid as they were conferred. (According to the internet, one dollar in 1866 would equal fourteen dollars and eighty two cents today.).

Within the pages of these old record books may be found a fund of interesting information and incidents of days long gone by. It is not difficult to read between the lines and see something of the progress of civilization, to understand something of the trials and disappointments of those hardy pioneers and to realize the stern purpose and sterling character of those men who laid not only the foundation of Masonry but also the groundwork of civil government in Humboldt County. An intensely interesting volume might be gathered from these old records. A few have been selected which might be interesting to you.

Our first written record of the proceedings of this Lodge dated from October 4, 1866 and are continuous to date. Many of them are notable for their brevity and it is somewhat difficult to determine what action was had or intended.

The minutes of this meeting are particularly interesting as they give a glimpse of Masonry at work in these early

days. For the meeting was evidently called to provide aid to a brother in distress. The records state that the committee in charge of Brother George S. Knight of Salem Lodge No. 4 of Oregon, rendered their report and the meeting was adjourned. However, the record of the meeting of October 20th following, clarify the matter as we find that bills were approved and paid for the care of Brother Knight as follows: Dr. Felt for medical services, \$100.00, Mrs Langdon for boarding, \$23.25 and B. Feigenbaum for pants, \$8.00 for a total of \$187.25. We are unable to find a place in the records where the Lodge was reimbursed for that amount. We believe that no comment is necessary, the story speaks for itself.

Many similar cases of Masonic relief are to be found throughout the records. We quote this one because it is a peculiar circumstance that the first written record shows that the meeting was called for the sole purpose of dispensing aid to a distressed member of another lodge.

We are looking forward to the time when we may again open Lodge and share our fraternal friendship.

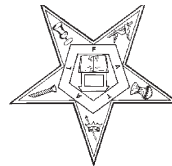

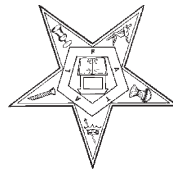

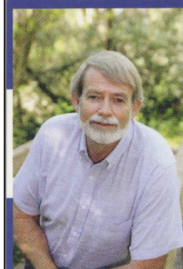
