
check for \$2K to help with their facility restoration project -the kids in the picture below are very appreciative! Our last charity event was providing a lift-chair to our beloved brother

Eel River Empire Lodge No. 147

History Continued

On August 27, 1868 a petition was received asking that this Lodge recommend that a dispensation be granted to form a new lodge at Ferndale. The petition was signed by L. B. Shaw, K. Gear, S. W. Morrison, F. Boynton, N. Patrick, H. S. Sole and Charles Cook and at the following meeting this Lodge recommended that such dispensation be granted. On March 7, 1903 Peter Corning deposited \$25.00 with the Lodge for the purpose of having a Masonic Emblem engraved upon his tombstone after his death. We can find no record of it, bit we presume that the money was eventually applied for the purpose intended. On November 19, 1904, the electric lights were installed in their hall at Rohnerville.

Here are a few of the early customs which attracted my attention. Fees apparently did not accompany the petitions for membership. They were paid for each degree as the members received them. It seems to be the custom for non-affiliates to pay dues regularly into the lodge in whose jurisdiction they lived. It was the custom to appoint an investigation committee in open lodge and a ballot was always taken, even when the report was unfavorable. For many years the Lodge installed their officers at 1:00 PM on the afternoon of St. Johns Day in December and at the one installation I find that neither the Master or Wardens were present. Upon the death of a member the Master ordered all members to wear the usual badge of mourning for thirty days.

We select a few of the more prominent names from our early records. Thomas Hart, the first Master of this Lodge, was formerly a member of the Western Star Lodge, 1854 to 1857 and Western Star is anxious to secure a picture and other information concerning him for their records. To date I have been unable to secure any information concerning him of any relatives.

Jacob DeHaven, prominent in Humboldt County history was born in 1812 and crossed the plains by ox team in 1849, settling in Humboldt County in 1863. Served a Assessor in this county 1855 to 1859. He was the father of John J. DeHaven who served In various offices and was finally elected as judge of the Supreme Court of California.

Reason Wiley; Early Humboldt records show that this brother was proprietor of the American Hotel at Union Town, now Arcata. This was in 1853.

A. D. Sevier; This brother crossed the plains in 1850 and came to Humboldt County in 1851. He served two years as Sheriff and also a term as Supervisor. Father of Denver Sevier a prominent Humboldt County attorney and at one time Superior Court Judge of this county.

L. C. Beckwith; A native of Connecticut and spent his younger days on a New Bedford Whaler. He settled in Humboldt County in 1851. His wife was Caroline Cooper, the first white woman in Eel River Valley and the fourteenth white woman to enter Humboldt County.

Peter Hauck; Settled in Humboldt County in the fall of 1863. Operated a pack train between Arcata and the Salmon River for a number of years. Our Tiler's sword, still in use was presented to the Lodge by Brother Houck 1863.
