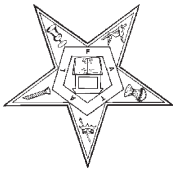

DeMolay counts among its alumni a multitude of gentlemen who transformed the lessons and examples from their DeMolay experience into the foundation of success in their personal or professional lives. 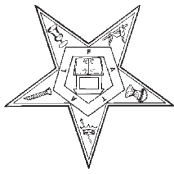

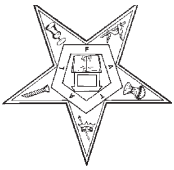

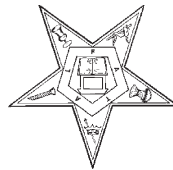
April Greetings Everyone,

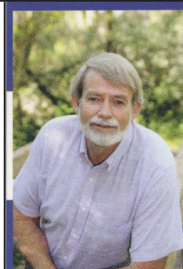
