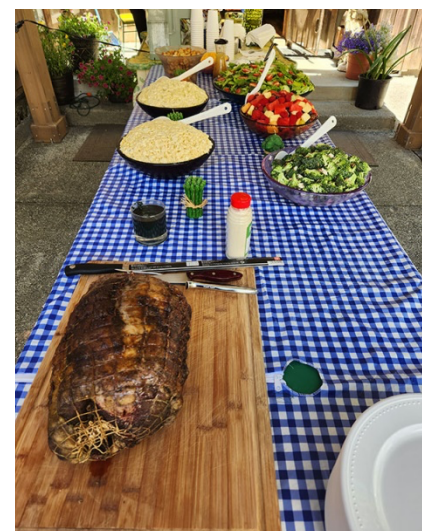

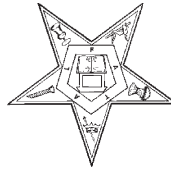
## Ferndale Lodge No. 193

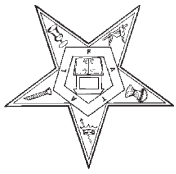

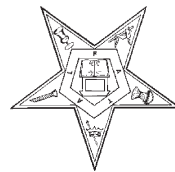
Salutations Masonic Family,
